**CIRCULAR**

In modification to earlier circular dated 2017-18-19 issued for the revision of fees of Vidyalaya Vikas Nidhi (VVM) in JNVs.

The Executive Committee in its meeting held on 17.07.2018 approved the revision of fees for Vidyalaya Vikas Nidhi (VVM) to maintain the quality and upgrade the facility in schools from eligible categories like Government Servants. Hence EC approved the proposal to enhance the fee of Rs. 600/- from Rs. 200/- per month in respect of students excluding students from Class VI to VIII, SC/ST students, Girl students and those from BPL families. However, in case of students from the family of Govt. Servants, the VVM of Rs. 1500/- per student per month may be charged irrespective of their category.
