

In continuation to this office letter dated 20.12.2017 regarding revision in Vidyalaya Vikas Nidhi (VVN) and clarification in this regard issued vide circular dated 12.02.2019 it is further clarified with the approval of the Executive Committee conveyed in its XXXVI meeting dated 06.03.2019 that –

"In respect of wards of Government Employees other than exempted category (students of class VI to VIII, all SC, ST and Girl students, wards of BPL families). VVN is to be charged either @ Rs. 1500/- per month or actual Children Education received by the parent per month whichever is less. Such Government Employee have to produce a certificate from the employer

mentioning the C.E.A. admissible in their organisation, if the CEA received is less than Rs. 1500/- per month. However, VVN charged shall not be less than Rs. 600/- per student per month.

Now, keeping in view all instructions related to collection of Vidyalaya Vikas Nidhi following is evident -

(i). students of following categories are exempted from paying Vidyalaya

Vikas Nidhi, irrespective of being wards of Government Employees -

01.All students from class VI to VIII.

02.All Girl students.

03. Students belonging to SC category

04. Students belonging to ST category.

05. Wards of Below Poverty Line families.

(ii). Vidyalaya Vikas Nidhi (VVN) is to be collected @ Rs. 600/- per student per month (except from the students of exempted category).

(iii). In respect of wards of Government Employees other than exempted category (students of class VI to VIII, all SC, ST and Girl students, wards of BPL families), VVN is to be charged either @ Rs. 1500/- per month or actual Children Education received by the parent per month whichever is less. Such Government Employee have to produce a certificate from the employer mentioning the C.E.A. admissible in their organisation, if the CEA received is less than Rs. 1500/- per month. However, VVN charged shall not be less than Rs. 600/- per student per month" in case of non-exempted category.
