

All the reports are to be countersigned by the concerned District Magistrate/Commissioner/Collector.
- (ii) All the pages of the report are to be signed by all Members and Chairperson of the Site Inspection Team.
- (iii) Copy of offer letter of the State/UT Govt. and rough sketch, etc. of the permanent site alongwith photographs of the permanent/temporary site are to be attached.
- (iv) The Site Inspection Report of the Permanent/Temporary Site are to be forwarded by the Deputy Commissioner, NVS Regional Offices with clear recommendations/non recommendation for setting of the JNV at the inspected site(s).
