#### **TERMS & CONDITION FOR BIDDING**

The Vigyan Jyoti Project is duly sponsored by Dept. of Science & Technology (DST) for promoting interest among the selected girl students in the field of Science. In order to facilitate academic excellence through online classes Agencies already having the experience in this field are invited to empanelthem to deliver online academic additional support for scholars of Classes XII (Phase II) and XI (Phase III). It is aimed to hire the academic support agencies which will help them with clarity in concepts and skill to face the competitive examinations. This is an endeavor to provide them the best in class exposure and academic support towards competitive examinations with specialized experts.

Department of Science and Technology, Government of India has sanctioned the project "VigyanJyoti" to Navodaya Vidyalaya Samiti for an enriched support to girl students through JNVs with specific focus on improving their increased participation in pursuing STEMas a prospective career. Main features of the project are as below:-

- Vigyan Jyoti initiative will provide a smooth journey to meritorious girl studentsright from School level till career in S & T.
- JNVs will act as Vigyan Jyoti Knowledge Centres (VJKC) to cater to around 50 girls from each centre belonging to JNV and nearby centrally funded Schools for more diversity in STEM. The programme will be conducted for girl students of class XI and XII.
- Monthly activities under Vigyan Jyoti program include the followings :
  - a) Science Camp
  - b) Visit of KPs
  - c) Workshop at ATL
  - d) Interaction with Role Model
  - e) Student-Parents Counselling
  - f) Visit of other R&D Lab/Industry/NGO
  - g) Lectures (6-8) / special classes

To address this pertinent issue, JNVs have been set as Centres to provide high quality education to the students at the Senior Secondarylevel, especially to the students from underprivileged backgrounds in the District. This initiative also hopes to attract ambitious and talented students in the JNVs and nearby Govt. schools who otherwise would not have access to specialized coaching.

#### 01. The Area and Scope for Academic Support:

Offer of expression of interest is invited by N.V.S. RO Bhopal from the eligible agencies for Academic support for the girls students of Vigyan Jyoti based on following Terms & Conditions, Area & Scope along with eligibility criteria and other requirements as given below:-

The Area of Scope for Academic Support Agencies is to deliver online academic support for class XII and XI is proposed as follows and to be included in Technical Bid Document:

- a. Online classes will be provided to students studying in Class XII and Class XI towards preparation for National level/State level Engineering/ Medical entrance examinations such as JEE Mains, JEE Advanced, NEET, AIIMS etc. The medium of delivery of content should be in a language which fulfils the needs of students. It can be bilingual / Hindi/ English.
- b. The classes will include Live classes (pre-recorded sessions not allowed) an interactive board with help of images, GIFs etc. to help understand concepts in a better way.
- c. The best quality study material including Assignments in the form of both soft and hard copy will be provided to students (*viz.* notes, assignments, quizzes, question banks & earchives etc.).
- d. In Live Online Classroom Programs, students will get dedicated live doubt clearing sessions. Agencies shall keep enough time to attend the queries of students.
- e. Online Parent-Teacher Meeting (E-PTM) which is an integral component of Live Online Classroom Programs. Agencies will provide suggestions and feedback once in every month.
- f. The online academic support will be provided through web-based latest technology. The technology should be user friendly and seamless to the children to attend the online classes through Laptop/PC/TAB/Mobile, etc. from home or JNV. Also, recorded lectures will be provided to students who miss live classes.
- g. The technology should facilitate two-way communication between children and faculty through video, voice, and text also. Along with the live lectures, students will have the facility to ask doubts to get a better insight in to the various concepts.
- h. The online classes will be organised for the subjects Physics, Chemistry, Math and Biology only covering Board syllabus as well as complete syllabus of IIT-JEE/NEET/KVPY.
- i. Agencies will categorise students into 3 groups based on performance:
  - 1) Category 1- High Potential (Aiming for advanced and for AIIMS and Reputed Medical Colleges)

- 2) Category 2- Medium Coverage (Aiming for only Mains /NEET & State Medical College)
- 3) Category 3 Average level Potential (Focus on some other courses from Basic Sciences)
- j. Grading of JNVs is to be done by the agencies based on the performance and participation of the students

#### **02.**Career Counselling

The academic support facility will be provided to Girl students of Vigyan Jyoti. Counselling session will be the part of contract. It will include counselling sessions on psychological, Career oriented and boosting self-confidence and self-belief.

#### 03.Additional Area & Scope of Academic Support

The following facilities should also be provided by the selected Academic Support Agency as part of Online Classes as additional area and Scope and will be the part of Technical Bid:

#### a) Online Testing:

- Class Tests in form of quiz
- Regular Online Topic-wise Internal CommonTests and Assignments
- b) **All India Internal Test Series:** These tests make students acquainted with a diverse set of examination patterns and alongside confer them with their National level performance ranking in the respective patterns. Tests will be based on the common minimum syllabus of class XII and XI as per School Integrated Programs.
- c) Chapter-wise Practice Problems: On each chapter students will be given chapter practice problems which they have to attempt and submit before the beginning of the next chapter. These solutions will be checked by the faculty members and then would be returned to the students with remarks and suggestions, thus helping every student to have a very strong command over fundamental conceptual knowledge, which is very crucial for getting Top ranks.
- d) Class Learning Improvement Program: Attempts will also be made to further help them get a higher Rank/ performance in JEE (Main & Advanced) & Other Engineering EntranceExams and NEET through Class Learning Improvement Program for those who have completed all assignments.
- e) **All India Computer Based Test Series:** To be conducted at the National Level on the present & expected pattern of NEET/ JEE (Main &Advanced).
- f) Practice Mock Test Papers for XI- XII Board Exam which will include the following:

- (i) Video archives: All recordings of the live classes would be available to the student for revision purpose. The students may watch the recordings as and when they wish without any limitations.
- (ii) **Study material:** The regular study material of the coaching institute for their regular classroom coaching should also be provided to the students of Vigyan Jyoti in soft as well as hard copy on exact cost to cost basis for both classes XI and XII. The class XI student will get study material and Assignments related to class XI and XII (2 sets at a time) and class XII student will get study material and Assignments related to class XI and XII (2 sets at a time) and both sets will have to be provided in Soft and Hard. Assignmentsandanswer key can be given later on as and when the particular topic is covered.
- (iii) Online doubt sessions: Facility of online doubt session shall be provided.
- (iv) Weekly practise test: Weekend Test subject —wise have to be conducted as part of continuous assessment. The efforts should be taken to conduct Periodic tests.
- (v) **Academic Help desk:** A single point of contact shall be assigned to students with whom they can share their learning difficulties or relatedrequirements, if any.
- (vi) **Students' performance:** Students' performance in each test shall be shared with the JNV Principals to ensure that parents are regularly updated.
- (vii) Online Test Series for NEET/ JEE Main + JEE Advanced + KVPY online testing Platform
- g) Performance Analysis and Feedback
  - Online LIVE Test Analysis
  - Rank Potential Index for each student
  - Preparation of Dashboard for Students, teacher, school and NVS wherein student should be able to get feedback about her responses Concept wise, Question wise, Area wise and Subject wise.

# 04. ELIGIBILITY CRITERIA FOR SELECTION OF AGENCIES FOR ACADEMIC SUPPORT CLASSES

The following factors will be considered for selection of the agencies for academic support classes:

- (a) Professional presence and five years of academic experience on similar line will be required (Copy of registration & other related documents will be obtained).
- (b) The bidding agency must have a high success ratio in competitive examinations. The details for the last five years will be considered, i.e., 2016-17 to 2020-21.
- (c) Last 5 Years (2016-17 to 2020-21)-Optimum batch size and Student Teacher ratio separately for online and offline classes may be obtained (Documentary proof will be obtained).

- (d) The bidding agency must be training more than 5000 students (through physical and online classes) per year for various competitive examinations throughout the nation having their centres. The details for the last five years will be considered, i.e., 2016-17 to 2020-21.
- (e) Number of selections in IIT (Mains and Advance), NEET and KVPY for last 5 years (2016-17 to 2020-21) with evidence.
- (f) Success Ratio in JEE Advanced, NEET& KVPY- Calculated as ratio of number of selections to the number of students registered at the institute for last 5 years will be required.
- (g) Institute providing Special Scholarship for girl Students for last 5 years will be required with evidence.
- (h) The bidding agency must have its own experienced teaching staff and should have rigorous selection criteria for hiring of their teachers. The details of those teachers along with their brief profile and credentials will be provided who will be engaged for providing online classes to the students of Vigyan Jyoti.
- (i) The bidding agency should have its own technical Know-how on conducting live online classes. Evidences of expertise will be provided by the bidder.
- (j) The bidding agency should have its own testing and test analysis platform that is readily available to the students. In addition to this it should have its own platform for analytical feedback to the students.
- (k) The bidding agency should have its own study material that is constantly updated according to the changes in various competitive examinations.
- (1) Financial strength & financial background for last 5 years will be required and certified copies of Final Accounts will be obtained, wherein the Annual turnover for last 5 Years and net profit before tax for last 5 years will be provided duly certified by Chartered Accountant/ Cost Accountant.

#### 05.CRITERIA FOR FINANCIAL BID

After analysis of Technical Bid & further decision on Technical Bid, the Financial Bid will be opened (which will be separate for both the classes) and decision will be taken by the committee.

The criteria for financial bid are as follows:-

- 01. The class wise reserve price for the whole period to provide academic support to XII students of VJ per JNV and Class XI students per JNV (Which includes the academic support and providing the resource material) for virtual classes through agencies has been decided by NVS, R.O for financial bid. In case the package price quoted by the bidders are more than the reserve price, then it will be decided by NVS,R.O and then the reserve price will be disclosed so as to decide the quoted rate up to reserve price for approving the panel for academic support.
- 02. The complete academic package for Class XII will include the following activities:
  - a) The online academic support classes will be for Class XII
  - b) The batch of the class will be 50 girl students per JNV
  - c) The online classes will be 3 days in a week ie. Monday, Wednesday, Friday and per day 2 classes will be organised

- f) The doubt clearing session will be conducted separately twice in a month probably on first and third Saturday of every month.

- i) The duration of Test will be 3 Hours.

- k) E- PTM will be conducted once in a month and feedback will be provided to the principals or concerned JNVs. Teacher coordinator of each JNV will be present in E-PTM
- 1) The level of online classes for Class XII students have already been defined and will be the part of package.
- m) The Subject and syllabus to be covered in the online classes for class XII students have already been defined.
- n) A single point of contact shall be assigned to students with whom they can share their difficulties or requirements, if any, with Academic Help Desk.
- o) The classes will be conducted from 16<sup>th</sup> December 2021 to till the completion of the competitive examinations ( JEE -advance)/NEET,AIIMS.JIPMER,PGIMER, etc..)in the above package and the probable academic days for special classes during this period will be 110±15 days. It is mandatory to conduct the minimum number of classes as defined above failing which amount may be deducted on prorata basis.

#### 03. The complete academic package for Class XI will include the following activities:

- a) The online academic support classes will be for Class XI
- b) The batch of the class will be 50 girl students per JNV
- c) The online classes will be 2 days in a week ie. Tuesday and Thursday and per day 2 classes will be organised
- d) The duration of one class will be 60 minutes.
- e) Academic Agencies will be taking separate sessions for both the regions
- f) The doubt clearing session will be conducted separately twice in a month probably on first and third Saturday of every month.
- g) The duration of Doubt Clearing Session will be 60 minutes and having + variation of 20 minutes.
- h) The Online Tests will be conducted separately twice in a month probably on second and fourth Saturday. The area and mode of online Test to be covered has already been defined.
- i) The duration of Test will be 3 Hours.
- j) The study material in the form of soft and hard copy as already defined will be the part of package.
- k) E- PTM will be conducted once in a month and feedback will be provided to the principals or concerned JNVs. Teacher coordinator of each JNV will be present in E-PTM
- 1) The level of online classes for Class XI students have already been defined and will be the part of package.

- m) The Subject and syllabus to be covered in the online classes for class XI students have already been defined.
- n) A single point of contact shall be assigned to students with whom they can share their difficulties or requirements, if any, with Academic Help Desk.
- o) The classes will be started from 16<sup>th</sup> December 2021 to 30<sup>th</sup> June 2022 in the above package and the probable academic days for special classes between this duration will be 100±15 days. It is mandatory to conduct the minimum number of classes as defined above failing which amount may be deducted on prorata basis.

#### 06. Other Terms & Conditions are defined as follows:-

Tender for the Providing the service as specified in Tender/ EOI shown in the attached statement are invited by the undersigned on behalf of Navodaya Vidyalaya Samiti up to 04:00 P.M. Date. 6.12.2021. The tender should be sent under sealed cover marked as "TENDER FOR PROVIDING THE SERVCES AS EXPRESSION OF INTEREST". The tender will be opened in the Office of the Deputy Commissioner, Navodaya Vidyalaya Samiti, Regional Office, Bhopal on 7.12.2021 at 10.00 AM. The Expression of Interest (for both the classes- XI & XII) is under Two-Bid System. i.e., Technical Bid and Financial Bid. Those who will qualify the Technical Bid will be eligible for comparison in Financial Bid.

- 01. The EMD is Rs2,00,000/- and the security deposit is Rs 3% of the estimated cost.
- 02. The amount of E.M.D. or / and security deposit shall be retained by the Samiti as a safeguard against the services of Firm/party/C.A up to the period of Contract.
- 03. The penalty will be imposed in case:
  - a) If the agency does not adhere to the agreed upon timelines penalty may be imposed by deducting the amount on prorata basis.
  - b) If the sessions are not completed as per the circulated timelines half of the amount shall be deducted for the session completing late on prorata basis.
  - c) If the lessons are not completed penalty shall be imposed at RO level for deduction of amount on prorate basis depending on the duration of Late periods.

- 07. The expression of interest is invited for academic support and the services will be taken for both the classes from the same (single) agency only. On opening of financial bid, if different agencies have quoted lowest for class XI &XII, then the panel of agencies will be finalized on the basis of calculation of total lowest amount

quoted for both the classes taken together. The total lowest amount will be calculated for both the classes put together as given below:

# The total lowest amount = Amount quoted for class XI \* No of JNVs in both the ROs + Amount quoted for class XII \* No. of JNVs in both the ROs.

- 08. There should not be any over writing, corrections in the Tender/EOI. If a figure is to be amended, it should be neatly scored out and then revised figure should be written above and the same should be attested with full signature and date. In the absence of the attested signature the tender is liable to be rejected. Party may secure their rates by covering quoted with transparent tape also.
- 09. If the Party fails to provide the services as depicted in tender article within the time, the Dy Commissioner, NVS,R.O Bhopal shall be at liberty to take the similar services from the other reputed agencies, Person or firm and the difference of price/package, if any, shall be deducted from the earnest money/security deposit/Bank Guarantee and incase any amount in excess of the security deposit/Bank Guarantee is paid by the Dy Commissioner, NVS,R.O, Bhopal then Party shall be liable to pay this amount.
