SKILL TEST FOR PROMOTION TO THE POST OF COOK (JNV CADRE)

Navodaya Vidyalaya Samiti (NVS) proposes to conduct Skill Test for promotion of Mess Helper to the post of Cook (JNV Cadre) by inviting applications from the eligible candidates. The eligibility conditions for the post as per Recruitment Rules in vogue are as under:

"From amongst the Mess Helper of JNVs of the concerned Regional Office having 03 years of regular service in the grade in the Samiti, subject to passing skill test to be decided by Competent Authority".

- 2. The cut off date for eligibility criteria for the post of Cook will be the closing date of submission of online application. Candidates possessing 03 years of regular service as on cut off date will be eligible to appear in the Skill Test.
