This has been viewed very seriously by the Ministry of Human Resource Development, Department of School Education & Literacy and has directed that NVS may set in place a system whereby the examinee students/parents can directly contact a senior officer in NVS in case of emergencies like non issue of hall ticket/admit card/roll number etc. to the students.
