The employees who are posted in their Home district and proposed to be declared as "Deemed" in ATD 2022 must note that if they fail to accommodate themselves in stations other than their Home Distt. shall be shifted under administrative compulsion after accomplishment of the Annual Transfer Drive 2022.

IMPORTANT NOTICE

Notification for Home District Stationed Employees of JNVs - To be taken up in ATD 2022

While analyzing the integrated database of "ShaalaDarpan" and "Transfer portal", it has been noticed that a considerable number of employees are posted in their **HOME DISTRICT** as per service records. **Such posting clearly goes against the spirit of Transfer Policy.** Since inception of the transfer policy, there has been ample opportunity to such employee to take transfer and accommodate themselves at a station of their convenience in light of the provision mentioned above. A considerable number of employees still enjoy protection by declaring their status as "**Protected Deemed**" on account of being covered under any of the priority categories.

This way such employees continue to stay at the station against the spirit of the policy and simultaneously keep on depriving the other employees of opting for those stations. Therefore, going along with the spirit of the transfer policy, it is for information to all concerned that;

1. All employees who are posted in their home district and have completed mandatory tenure (as applicable cadre wise) shall compulsorily be "**Deemed Vacancy**" under ATD 2022, no matter even if they are under other valid protective clause (Medical / Spouse / Single Lady / DFR).
2. In case of **NVS spouse**, besides compliance of provision in point no. 01 above, the employees stationed in home district his / her spouse and would complete mandatory tenure (as applicable cadre wise) at present home station shall also be declared to be "**Deemed Vacancy**" under ATD 2022.
3. Considering "**Request Basis Transfer**" as the prime spirit of **NVS transfer policy**, such employees who are posted in Home district and have not completed mandatory tenure (as applicable cadre wise) at their present station, may be notified that their status may be declared "**Deemed Vacant**" under ATD 2022 on completion of mandatory tenure (as applicable cadre wise), no matter even if they are covered under any other valid protective clause.
4. Cases of exception may be kept outside of this exercise as per provisions. Such cadres may be as under:
 - i. Employees of all cadres, covered under valid PH category.
 - ii. Employees belonging to the Cadre of Electrician-cum-plumber, Laboratory Attendant, Driver, Cook, Mess Helper, Chowkidar and Chowkidar-cum-Sweeper.

In view of the above, following must be ensured without any further delay:


- a. The Deputy Commissioner of All Regional Offices must evaluate all cases in which the employees are posted in Home Distt. It is also required to submit details of Home district stationed employees to NVS HQ on email "dcpers.nvs@gov.in" latest by 2002.2021 in the appended proforma (in pdf and excel):

- b. The Deputy Commissioner of All Regional Offices must inform all employees (through the Principal of the JNV) of the region about this important exercise in order to keep the employee well informed in view of giving them final chance to accommodate themselves conveniently in next ATD 2022.
- c. The employees who are posted in their Home district and proposed to be declared as **“Deemed”** in ATD 2022, must note that if they fail to accommodate themselves to stations other than their Home Distt, shall be shifted under administrative compulsion after accomplishment of the Annual Transfer Drive 2022.

This issues with the approval of the competent authority.
