### **TERMS AND CONDITIONS FOR THE YEAR 2021-22**

Sealed Tender for the supply of **Provisions(Groceries) & Hygiene(Toiletry) Items/Washing and Pressing of Uniforms/Bakery items** are invited by the undersigned w.e.f **13.09.2021** & sealed tenders will be accepted up to **04.00 P.M** on **25.09.2021**. Tender should be sent under strong sealed cover marked as Tender for the supply of \_\_\_\_\_ and addressed to the Principal, Jawahar Navodaya Vidyalaya, Bagalur, Bangalore North - 562 149. The Tender will be opened on **27.09.2021** at 11.00 am in the office of the Principal, Jawahar Navodaya Vidyalaya, Bagalur, Bangalore North in the presence of the tenderers presented.

1. The tender shall be submitted accordingly to the terms and conditions specified in paragraphs 2 to 27 Unless specified otherwise in the tender it shall be construed that the terms & conditions stipulated hereunder have been agreed to.
2. The firm should tender the rates in the prescribed application form purchased from the JNV in original or in the downloadable copy of the application form downloaded from the official website of the Vidyalaya (<https://www.navodaya.gov.in/nvs/nvs-school/BANGALOREURBAN/en/home/> and CPP Portal) along with the application fee of Rs 200/- by Demand Draft and the requisite EMD (mentioned in the Point No. 8) within the stipulated time strictly adhering all the other conditions of the tender documents. Submission of rates in any other formats (in own letter pads stating their own brand & specifications) other than the brand & specifications stated in Tender Document of this Vidyalaya will not be entertained.
3. The rates should be F.O.R. and should include GST, freight charges, any other taxes rates or imposition whatever liable in respect of the supplies. The Vidyalaya shall not be liable to pay any tax, any freight etc.
4. There should not be any overwriting or corrections in the tender. If figure is to be amended, it should be neatly scored out and the revised figure written above and the same attested with full signature and seal of the firm with date. In the absence of attested signature the tender is liable to be rejected.
5. The undersigned does not bind himself/herself to accept the lowest tender and reserve the right to accept the tender in whole or in part i.e., with respect to articles mentioned in the attached statement or in respect of any one or more than one article specified in the attached statement.



6. On acceptance of the tender it will become a contract and shall be bound by the terms and conditions of the tender.
7. Along with the supply of items the contractor has to furnish the Original bill/invoice (which will be containing the CST/KST/VAT/GST registration Nos) for necessary payment from the funds of Jawahar Navodaya Vidyalaya, Bangalore Urban District.
8. The tenderers should enclose the Demand Drafts as per the following details towards the EMD.

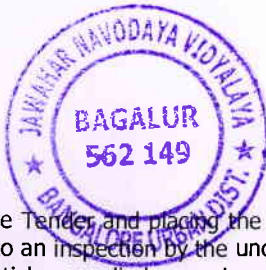
9. The liberty to carry out negotiations or accept the lowest tender as such is vested with principal and will be exercised after opening/compiling the same. TIN No. of the supplier should be given in the bill.
10. The Tenderers should have a registered firm/Bakery/shop in their name and the tenders will be awarded after physical verification of firm/Bakery/Shop.
11. Details of tax paid and the copy of income tax return for the year 2020-21 should be attached along with the tenders.
12. **a.** A Demand Draft AS STATED ABOVE drawn on any Nationalized Bank payable at State Bank of India, Bagalur Branch (Branch Code No.21733) Bangalore Urban District & IFSC Code-SBIN0021733 in favour of "The Principal, Jawahar Navodaya Vidyalaya, Bagalur" towards E.M.D should be enclosed with the tender and the same will be returned to the unsuccessful bidder.  
**b.** The amount of EMD will be as per Point No. 8 + Rs. 200/- if the tender schedule is downloaded from the Website/CPP Portal failing which the tender will be rejected.

**13. No Cheques will be accepted as EMD.**

14. An awarded tenderer should remit Security Deposit to this Vidyalaya as mentioned below. The Security Deposit will be refunded only after successful completion of the tender period.

If the contractor fails to supply the articles within the stipulated time as per the supply order, the undersigned shall be at liberty to purchase the articles from the market or get the rest of the contract completed by any other person or firm and the difference of price if any shall be deducted from the Earnest Money/Security Deposit and in case any amount in excess of the Security Deposit is paid by the undersigned, the contractor shall be liable to pay this amount.
16. Prior to acceptance of the tender, the undersigned reserves the right to call for sample or demonstration and the contractor shall be liable to supply the sample or give the demonstration free of cost.



17. In the event of acceptance of the Tender and placing the order for the purchase the articles ordered for would be subjected to an inspection by the undersigned or his representative and are liable to be rejected if the articles supplied are not according to approved samples or do not confirm to the specifications prescribed.
18. The rate quoted by the contractor shall hold good up to **31.05.2022** No amendment in the rate shall be accepted due to increase in the rate of Sales Tax/GST during the period of execution of the contract.
19. The contractor shall be required to fix a tin label on the lab equipment/other equipment supplied by him, giving his name and year of manufacture.
20. Tender which do not comply with the above conditions are liable to be rejected.
21. These instructions to tenders are to be signed by the contractors and returned with the tender.
22. It is not mandatory on the part of the Vidyalaya to purchase of Provisions(Groceries) & Hygiene(Toiletry) Items/Washing and Pressing of Uniforms/Bakery items for which the tenders are called. Orders will be placed on the basis of requirement and availability of the funds.
23. The Principal reserve the right to call any party for negotiation to avoid piecemeal supply in the interest of the Vidyalaya if no single party emerge out in the tender process.
24. The sealed tender along with the samples should reach the undersigned on or **25.09.2021 by 04.00pm** by SPEEDPOST/REG.POST/COURIER/BY HAND. Rates without sample will not be considered for comparison. No request will be entertained.
25. The rate for the brand, if it is mentioned in the tender for which rate to be quoted, tenderer shall have no right to mention their own brand or any other quality.
26. No conditional tender will be accepted.
27. **The decision of the PAC Chairman is final for Rejection/Acceptance.**
