Sub: Promotion of Stenographers to the post of Personal Assistant – Reg.

Limited Departmental Test for promotion to the post of Personal Assistant from amongst Stenographers of the Samiti is scheduled to be held online soon. Eligible candidates are required to apply for the post of Personal Assistant under promotion quota.

2. Number of vacancies

There are 04 vacancies including anticipated vacancy of Personal Assistant to be filled up under promotion quota. The category wise breakup is given below:-

| Sl. No. | Category | Number of posts |
|---------|----------|-------------------------------|
| 1 | UR | 03 (including 01 anticipated) |
| 2 | ST | 01 |

3. Eligibility conditions:

Stenographers with 10 years of regular service in the grade in the Samiti subject to passing a departmental test for Shorthand/Typing speed as indicted below:-

- (i) Shorthand speed of 100 words per minute and typing speed of 40 words per minute in English;

OR

- (ii) Shorthand speed of 80 words per minute and typing speed of 40 words per minute in Hindi

The skill test, referred to above, for promotion of Stenographers to the post of Personal Assistant will be qualifying in nature. Mere qualifying in the said test does not vest any right on the candidate to get promotion to the post of Personal Assistant. Promotion of qualified candidates will be decided on the recommendation of DPC based on the seniority, performance in ACRs, vigilance clearance and integrity certificate.

4. All eligible candidates are requested to be alert and watch Samiti's website for publication of separate intimation for conduct of online test. The detailed instructions and guidelines regarding filling up of online applications and date for conduct of skill test will be intimated therein. It is further to intimate that communication for holding online departmental test will be notified by Samiti in respect of various posts including the post of Personal Assistant.
